## COVID-19 Liability Release and Screening

---

### Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. Evidence has shown that COVID-19 can cause serious and potentially life threatening illness and even death.

Disciples Crossing Camp cannot prevent you [or your family, or group] from becoming exposed to, contracting, or spreading COVID-19 while utilizing Disciples Crossing's services or premises. It is not possible to prevent against the presence of the disease. Therefore, if you [and your group] choose to utilize Disciples Crossing's services and/or enter onto Disciples Crossing's premises you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

**ASSUMPTION OF RISK:** I have read and understood the above warning concerning COVID-19. I hereby choose to accept the risk on behalf of my group of contracting COVID-19 for myself and/or my family in order to utilize Disciples Crossing's services and enter Disciples Crossing's premises. These services are of such value to me [and/or to my family and group] that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to utilize Disciples Crossing's services and premises in person.

**WAIVER OF LAWSUIT/LIABILITY:** I hereby forever release and waive mine and my group's right to bring suit against Disciples Crossing and its owners, officers, directors, managers, officials, trustees, agents, employees, or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to utilizing Disciples Crossing's services and premises. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

### Refunds and Cancellations

**COHORTS/GROUPS:** To the best of our ability with the facilities available, groups will be separated into groups or cohorts that remain consistent over the camp session, and we will discourage mixing between groups or cohorts. Groups/cohorts will be defined by geographic origin, age/grade, or bunks with dining/activity cohorts that may include single or a group of bunks.

**REFUNDS:** If an event is cancelled by Disciples Crossing for health and safety reasons groups/cohorts or individuals will not incur any charges and any fees previously paid will be refunded. We are unable to

offer refunds for groups/cohorts or individuals who are required to leave after an event begins, or who are no-shows due to failed screenings the day of arrival.

## Rapid Testing

Disciples Crossing is approved by the Texas Division of Emergency Management (TDEM) as a licensed Youth Summer Camps by the Texas Department of State Health Services to obtain, free of charge, Abbott Labs BinaxNow Rapid Antigen tests for use on staff and campers during the summer months. Tests are available to any individual participating in an event at Disciples Crossing through the end of Summer 2021. Tests will be conducted by a trained Testing Coordinator and test recipient information, including test results and personal identifying information, will be reported to the TDEM.

We will not conduct rapid tests on minors without prior approval from a legal parent/guardian, and tests are not required for participation in Disciples Crossing events.

In the event that a participant tests positive for COVID-19 they will be required to leave camp.

## COVID-19 Liability Release and Pre-Participation Screening Agreement

---

It is the group leader's responsibility to inform all individual participants of Disciples Crossing's policy and determine if they will perform screenings for all participants.

Face coverings and social distancing guidelines are welcome, especially while indoors, and shall be determined and enforced by the group leader.

The following are Disciples Crossing's recommended screening questions.

Have you, in the past week, experienced any of the following new or worsening signs or symptoms:

- Fever measured at greater than or equal to 100.0 degrees Fahrenheit OR one of the following symptoms: cough, shortness of breath, difficulty breathing?
- Any of the above listed symptoms AND any of the following: chills, repeated shaking with chills, muscle pain, headache, sore throat, loss of taste or smell, diarrhea?
- Have you been in contact with anyone who has been diagnosed with COVID-19 and/or someone who is under investigation for having COVID-19?

I HAVE CAREFULLY READ AND FULLY UNDERSTAND ALL PROVISIONS OF THIS RELEASE, AND FREELY AND KNOWINGLY ASSUME THE RISK AND WAIVE MY RIGHTS CONCERNING LIABILITY AS DESCRIBED ABOVE ON BEHALF OF MY ENTIRE GROUP.
